If more than one candidate file nomination papers for the **same position**, an election will be held on November 1<sup>st</sup>, 2020 from 10 AM to 8 PM and an advance poll will be held on October 25<sup>th</sup>, 2020, from 12:00 p.m. to 8:00 p.m.

A revision period of the electoral list will be held from **October 3 to 13, 2020** for the wards in election only.

An elector who has no child admitted to educational services provided in a French *centre de services scolaires* or in an English school board which covers their home address may choose to exercise or revoke their right to vote at an English language school board. This choice is made by sending a signed "Notice of option or revocation" to the Returning Officer of the ETSB **no later than October 13, 2020 (10PM)**.

I nominate as Election Assistant: *Ms. Catherine Noiseux*.
